

MAY 2022 COMMISSIONER'S MEETING

Ed Nazario opened the meeting the pledge to the flag

Motion was made by Nick Niles to accept secretary's minutes and to pay the bills. It was seconded by Bob Price

CHIEF'S REPORT:

41 calls in April: 29 were EMS calls. Of the EMS calls 15 were BLS and 14 ALS

E-342 the intake valve handle is bent and not getting the full intake. Randy Sisson has worked on it over the years. The price to repair it is \$2,100. This is going to be put on the weekly truck check sheet and water should be run through it once a month. Justin is going to talk with the insurance representative Gary Gugino about having it go through the insurance. Motion was made by Alex and seconded by Don.

Nick Niles made a motion to buy a new pike pole. The cost \$150.00 and seconded by Bob Price.

Charlie will be going to the fire expo in Harrisburg, PA and would like to purchase boots, gloves, and nomex hoods:

6 pair of boots \$359.00 a piece

10 pair of extrication gloves \$65.49 a piece

6 nomex hoods \$124.59 a piece

6 pair of fire gloves \$153.00 a piece

These items may be cheaper at the expo.

9 fire belts were also discussed for a cost of \$2,070.00. Motion was made by Don and seconded by Alex not to exceed \$6,600.00

It was discussed that no fire gear will be bought at this time.

Charlie and Justin will be going to the fire expo in Harrisburg, PA. Charlie had found a room at the Country Inn & Suites costing \$214.90 a night. They will travel on Friday night and come home on Saturday. Lorri will make the hotel reservations for them with the business credit card. The amount not to exceed \$350.00. Motion to accept was made by Nick and seconded by Bob.

Ambulance billing was discussed. Falconer and Celeron are billing the patient. Lisa will get a copy of Celeron's contract and Dan will get a copy of Falconers contract and we can do a comparison and see what we might want to do. Nick will be a representative for us. An ambulance billing committee was set up. On that committee is Donna Elderkin, Dan Sisson, Lisa Piazza, and Justin Martin

Justin asked about getting a new reeves stretcher not to exceed \$400. Motion was made by Alex and seconded by Don
