Chiefs Report:

45 calls for the month of April

Chief Justin Martin would like to get 6 links of forestry hose for the Kubota. Motion was made by commissioner Don Mowry to get the hose and seconded by commissioner Bob Price.

Gas meters for the oxygen tank is broken. Send to get fixed. This will come out of the repairs to apparatus and equipment budget line.

Old Business:

Secretary/treasurer Lorri Munson will be going to Turning Stone to a conference on May 17th – 21st. Lorri can get gas at the school pumps before the trip and after the trip. Motion was made by Chairman Nick Niles and seconded by commissioner Bob Price.

FireArms Policy:

A concern of the fire company is that when they have their gun show that the people working there cannot wear their gun or any family member working the gun show cannot wear their gun. If there is a call and you come to the fire station you will have to secure your gun in your vehicle or if you have to come to the fire station for any reason your gun should be locked in your vehicle before you come into the station. Someone was going to look on the fire association's website to see if they had a firearms policy. Motion was made by chairman Nick Niles to table this discussion and seconded by Don Mowry.

Office supplies line on the budget:

The office supplies line is over spent by \$154.00. Chairman Nick Niles made a motion to transfer \$500 from minor equipment and put it in the office supplies line. This was seconded by commissioner Don Mowry.

The district owes \$237.00 to the attorney. We do not have money on that budget line. We received an overpayment check of \$700 from Southern Tier Trailer when we paid for the Kubota lights. The check shows deposited but it needs to go to minor equipment and then it needs to come out of that account and go to audit and legal fees to pay for the attorney fee. Motion was made by commissioner Don Mowry and seconded by commissioner Don Sparling.
